#### **Eligibility:**

Candidates who have successfully passed the qualifying exam (Graduation & Diploma during / after June 2021 and having secured minimum of 55% marks.

- 🚧 Candidates who have already completed apprenticeship or currently undergoing apprenticeship or already having one year or more of experience are not eligible to apply.
- 🚧 Post-Graduate students are not eligible.
- 🚧 Shall have standard of fitness as prescribed in the clause 4/ Schedule II of Apprenticeship Rules 1992, and amendments thereof, if any.

**Note:** \* - 55% marks aggregates of all semesters in the qualifying examination. In case of Universities / Institutes awarding CGPA / SGPA grading etc., grading to percentage formula to be provided. Else CMTI will adopt its own conversion formula.

### **General Instructions for Candidates:**

1. Candidates have to enrol themselves online in the National Web Portal <https://nats.education.gov.in> by providing required details and uploading the required documents to get User Id & Password.
2. For enrolment Candidates should have a valid email id, contact mobile number, Govt. ID (any one of Driving License, Voter ID, Passport or PAN card) , Aadhaar Card, Passport Size photograph (jpeg format less than 200kB), **DBT enabled Aadhaar linked bank account details.**
3. **The establishment shall pay only their share of the stipend and the government's share of the stipend will be directly credited to the bank account of the apprentice through BOAT(SR) only after generation of the contract number in NATS portal.**
4. After successful enrolment in the portal, the Candidates will be provided with a **student enrolment number.**
5. Web portal is being operated by MoE, Government of India. For enquiries regarding the issues related to web portal, the candidates are requested to contact the helpline numbers mentioned in the web portal (E-mail: [studentquery@boat-srp.com](mailto:studentquery@boat-srp.com), Helpline No.: 044-22542-703 / 236 / 235 or 9773895327 / 28. CMTI will not entertain correspondence with respect to portal functionality.
6. Indian Nationals only need to apply.
7. The Institute reserves the right to adopt its own method of short-listing criteria and is not obliged to shortlist all the candidates who fulfill the minimum requirement.
8. Any amendments/updates and list of the selected candidates will be hosted online in our website [www.cmti.res.in](http://www.cmti.res.in) or <https://cmti.res.in/apprenticeships/> only. Candidates are requested to visit the website for the same regularly.
9. No correspondence or enquiries from the candidates about the Apprenticeship will be entertained.
10. Canvassing in any form will be treated as disqualification.
11. No TA/DA will be paid to applicants for attending the document verification/ selection/ joining process. Candidates will have to make their own arrangements for stay, if required, during this process and also during their apprenticeship.
12. The selected candidates should be able to join the establishment on the prescribed date of joining. If the candidate does not report by the scheduled date, it is assumed that he/she is not interested in the apprenticeship, and his/her candidature will be forfeited.
13. Selected Apprentices can join CMTI as Apprentices only after getting approval from the BOAT.
14. The selected candidates must execute a contract for the period of training of 1 year as per the Apprenticeship Act. Engaging suitable candidates as Apprentices or the completion of training at CMTI, shall not entitle such candidates/trainees, any right to claim any type of employment in CMTI.
15. Mere fulfilment of requirements as laid down in the advertisement does not qualify a candidate to be selected Graduate / Technician (Diploma) Apprentice.
16. CMTI shall not be responsible for any application being rejected or candidate not shortlisted due to incorrect data.
17. If at any stage of training, it is found that the candidate has furnished false/incorrect information or concealed any information, his/her Training shall be cancelled and suitable action will be taken as per extant rules. CMTI reserves the right to Revise/ Reschedule/ Cancel/ Suspend the engagement process, if the need arises, without assigning any further notice or reason. The management's decision shall be final and no appeal shall be entertained.
18. Interested & eligible Candidates may register their names between **09:00 to 09:30 Hrs** on the respective day as listed above, failing which they would not be allowed to appear for the selection process of Document Verification followed by Interview – Physical mode only.
19. Candidates should bring all their **original certificates / mark sheets, Govt. ID proof, Aadhaar, Bank passbook (DBT enabled and Aadhaar seeded account)** & a recent passport-size **photograph**. Self-attested photocopies of all the above documents shall be enclosed along with the duly filled application.
20. After completion of one year of Apprenticeship training, candidates will be issued a Certificate from BOAT.
